

5. Declaration regarding the reason(s) for extension (*explain*):

The Debtor was in the business of purchasing and selling precious metals and buying and selling coins and bars. Prior to filing its bankruptcy case, the Debtor was having problems filling its orders. Customer complaints led to the United States Attorney in Charlotte, N.C. opening a criminal investigation into the Debtor's business practices. On or about March 9, 2014, the United States Secret Service, working under the direction of the U.S. Attorney's Office executed a search warrant and seized all of the Debtor's computers, files and records. Debtor's attorney has been in contact with the Secret Service and the Asst. U.S. Attorney about obtaining copies of the records necessary to complete the Debtor's bankruptcy filing. The U.S. Attorney has requested a list of the necessary information but has advised counsel that it could take approximately 60 days to provide the information

Debtor acknowledges that denial of this motion or failure to file the required documents by the extended deadline may result in dismissal of the case and a determination that the debtor is not eligible for any bankruptcy relief for 180 days.
