8 b. spreadsheets and account ledgers which set forth the details behind the  
9 transactions foregoing in MS Excel format; and  
10 c. copies of all underlying contract documents between Tulving Company and A-  
11 Mark;

12 4. A-Mark will provide assistance to the Trustee in reviewing the foregoing documents  
13 and A-Mark will produce additional documents and information if subsequently requested by the  
14 Trustee;

15 5. A-Mark shall submit to examination under oath by the Trustee upon twenty-one (21)  
16 days written notice; and

17 6. The Court shall maintain jurisdiction of this matter.
