

WHEREAS, the Court has considered the Application, the declaration of the Chapter 7 Trustee, all filings related to the Application, and the record in this case, and good and sufficient cause appearing therefor, **IT IS HEREBY ORDERED** that: The Application is granted, and the requested fees and expenses are approved, on an 1. interim basis to the extent provided herein. 2. Pursuant to its Application, BRG is awarded on an interim basis \$161,737.00 in fees and \$5,601.55 in costs advanced, for a total of \$167,338.55, with payment authorized at this time in the amount of \$80,868.50 (50% of fees) and \$5,601.55 (100% of expenses), for a total allowed payment of \$86,470.05. ###
