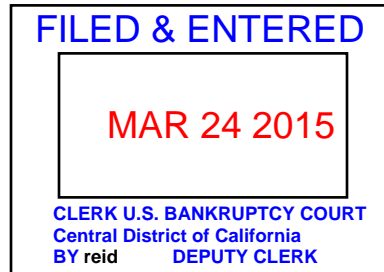

21 WHEREAS this matter came before the Court upon the submission of the following
22 application for approval of compensation and reimbursement of expenses (the "Application") filed
23 by the following professional employed by the Trustee of the above-captioned debtor during the
24 period this case was in chapter 11 (the "Chapter 11 Professional");

25 1. *First Interim Application of Berkeley Research Group, LLC ("BRG") for Allowance*
26 *and Payment of Fees and Expenses [Docket No. 217].*

1 WHEREAS, the Chapter 11 Professional does not seek payment at this time, but will seek
2 payment after subsequent administration of the Debtor's chapter 7 case, when the payment of
3 Chapter 11 administrative claims is authorized;

4 WHEREAS, the Court has considered the Application, the declaration of the Chapter 7
5 Trustee, all filings related to the Application, and the record in this case, and good and sufficient
6 cause appearing therefor,


7 **IT IS HEREBY ORDERED** that:

8 1. The Application is granted, and the requested fees and expenses are approved, on an
9 interim basis to the extent provided herein.

10 2. Pursuant to its Application, BRG is awarded on an interim basis \$32,306.50 in fees
11 and \$558.14 in costs advanced, for a total of \$32,864.64.
