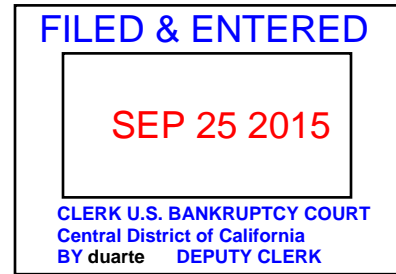

1 through their respective counsel, and based upon the record before the Court, and good and
2 sufficient cause appearing therefor,

3 **IT IS HEREBY ORDERED** that:

- 4 1. The Stipulation is approved.
- 5 2. The Trustee shall have an additional sixty (60) days to file a final list of victims and
6 losses and a plan for liquidation of the seized items pursuant to the *Order for*
7 *Coordination Agreement for Distribution of Seized Items From United States to*
8 *Bankruptcy Trustee And From Trustee to Victims* entered by the Court on July 22,
9 015 [Docket No. 264].
- 10 3. The Court shall retain jurisdiction to hear and determine all matters arising from or
11 related to the implementation or interpretation of the Stipulation and this Order.
