14 Mark Calvert, the Chapter 11 Trustee (the “Trustee”), applies to the Court pursuant to  
15 11 U.S.C. § 327 for authority to employ K&L Gates, LLP (“K&L Gates”) as attorneys for the  
16 Trustee. This application is made pursuant to 11 U.S.C. § 1103, Fed. R. Bankr. P. 2014, and Local  
17 Rule Bankr. P. 2014-1 for entry of an order confirming final employment of K&L Gates as attorneys  
18 for Chapter 11 Trustee.

19 In support of this application, the Trustee respectfully represents:

- 20 1. On April 1, 2016, the Debtor filed a voluntary bankruptcy petition under Chapter 11  
21 of Title 11 of the United States Code.
- 22 2. An order approving the appointment of Mark Thomas Calvert as Chapter 11 Trustee  
23 was entered on April 11, 2016.
- 24 3. On April 13, 2016, the Court approved the appointment of K&L Gates as attorneys  
25 for the Trustee on an interim basis, without notice to creditors (Dkt 60). Relationships of K&L
