1 No public policy has been identified or accounted for in this bankruptcy case. No  
2 reported reserves in place to cover the public policy of all the claims, administrators of  
3 the estate or trustees.

4 This is highly suspicious of a judge being connected with a dubious cast of characters  
5 in this great pretense in the district. There is a high probability the court is using delay  
6 tactics to cover other shadowy characters messing with the estate. This leads people to  
7 believe there is suspicious financial activities happening surrounding the estate affairs  
8 due to a lack of information available to the public and creditors.

9 The above is the foundation for why I need the bank account information to identify  
10 the creditor position and the debtor position in this case, and the reserves on deposit  
11 that cover public policy. The signatories on the accounts, transactions going in and out  
12 of the banks, what banks, where they are located in the district and the account
