- Motion for Order Establishing Procedures for Interim Payment of Fees and Costs to Professionals Employed by Trustee and Creditors Committee;
- Motion for Order Setting Deadline for Filing Proofs of Claim

The Court having considered the request to shorten time, and the pleadings and papers herein, and having found that good cause exists for **some of the requested relief,**

NOW, THEREFORE, Trustee's request is GRANTED **in part and DENIED in part and it is ORDERED as follows:**

1. The Trustee shall provide notice that a hearing on the Trustee's Motion for Case Management Order will be held on May 6, 2016, at 9:30 a.m., and any objections to that motion shall be filed by 5:00 p.m. on or before May 5, 2016;
2. The request to shorten time for the hearing on the other Motions is denied for lack of exigent circumstances; and
3. The Trustee may limit notice of the hearings on the Motions to the parties identified in his ex parte motion (Dkt. No. 97).
