1 electronic files, e-mail, and other electronic communications saved to or located on hard disks, file
2 servers, floppy disks, CDs, DVDs, backup tapes, thumb drives, or any other electronic media,
3 whether or not in tangible or electronic form.

4 3. Ross B. Hansen shall appear at the office of K&L Gates, 925 Fourth Ave., Suite
5 2900, Seattle, WA 98104 on seven days notice from the Trustee as to the date of the deposition and
6 give testimony regarding i) the acts and conduct of NWTM and its affiliates, (ii) the acts and
7 conducts of Mr. Hansen and any other party in control of NWTM, (iii) the property and liability of
8 NWTM's estate, (iv) any other matter which may affect the administration of NWTM's estate.

9 4. The Trustee's motion for subpoenas is GRANTED. The production of documents
10 from any third party which may hold the documents and records identified in Exhibit A may be
11 compelled via Rules 2004(c) and 9016, F.R.B.P;

12 5. This Order is without prejudice to the Trustee or other interested parties obtaining
13 further orders pursuant to Rules 2004 and 9016.

14 6. The Trustee is authorized to serve this Order on the attorney of record for Ross B.
15 Hansen and such service shall be deemed effective for the purposes of Federal Rules of Bankruptcy
16 Procedure 2004 and 9016.
