Kavli Prize Medals;

WHEREAS, Kavli asserts that it deposited gold with the Mint and ordered 2016 Kavli Prize Medals that it has not yet received;

THEREFORE, in light of the foregoing, Kavli and The Mint STIPULATE AS FOLLOWS:

1. The Mint and Kavli have entered into a production agreement under which the Mint has committed to produce nine solid gold and twenty-seven gold plated medals constituting the 2016 Kavli Prize Medals, in accordance with the production specifications supplied by Plaintiff and as described more fully in the Sales Order Acknowledgment attached as Exhibit A and Kavli has committed to provide raw materials and pay certain charges for the production and shipping of the finished product (the "Kavli Purchase Order").

2. The parties agree that the Kavli Purchase Order is a post-petition administrative obligation of the Mint and that Kavli's obligations under the Purchase Order are post-petition obligations which may not be netted against any pre-petition claims Kavli may assert against the estate.

3. Kavli shall provide at its cost the gold and plated gold raw materials (the "Kavli 2016 Gold") needed for the Kavli Purchase Order. The Kavli 2016 Gold shall be used solely for the production of the 2016 Kavli Prize Medals in accordance with the Kavli Purchase Order.

4. The Kavli 2016 Gold shall at all times remain the property of Kavli and held in a marked, segregated location at the Mint's production facilities. The Kavli 2016 Gold shall not be or become property of the bankruptcy estate and shall not be co-mingled with any other gold or gold-plated materials held by the Mint.

5. No later than four weeks after receipt of the Kavli 2016 Gold, The Mint shall ship on an insured basis (at Kavli's expense) the completed 2016 Kavli Prize Medals and any remaining Kavli 2016 Gold to Kavli c/o Nadine Stern at:

6. The Mint shall charge its customary charges (the "Kavli Contract Price") for the production of the 2016 Kavli Prize Medals (nine gold medals at \$850.00 per medal and twenty-seven gold plated medals at \$185.00 per medal) in accordance with the Kavli Purchase Order, payment due fifteen days after the order is received by Kavli.

7. In the event the Mint provides written notice to Kavli of the Mint's inability to timely perform its obligations under the Kavli Purchase Order Kavli may terminate the Kavli Production Order via email notification to the Trustee and his counsel (a "Kavli Termination Notice").

8. Upon issuance of a Kavli Termination Notice, the Production Agreement shall be deemed terminated and of no further force or effect; and the Mint shall promptly deliver any minted 2016 Kavli Prize Medals and any Kavli 2016 Gold remaining in the possession of the Mint to Kavli; provided that Kavli will pay for any finished medals delivered.

9. Nothing in this Stipulated Production Agreement affects the ownership of or rights in the dies or molds used to cast Kavli Award Medals, the prepetition claims of the parties, or any other rights or obligations between the parties.

10. In the event that the Production Agreement is terminated before the Kavli Purchase


