I, Rodger Overson, hereby declare as follows:

1. I submit this Declaration in support of the Trustee's Motion for Order Granting Authority to Return Stored Inventory, Other Customer Owned Inventory, and Coining Dies (the "Motion"). I am over eighteen (18) years of age, and I am competent in all ways to testify.

2. In the Trustee's declaration filed in support of the Motion, Mr. Calvert states that I am the owner of two gun safes located on the Debtor's property. The Trustee requests authority to return the safes and their contents to me. I provide this declaration to substantiate my ownership of the safes at issue and their contents, and request that the Court grant the Trustee authority to return the safes and their contents to me.

3. Over the course of several years, I purchased large quantities of silver from

1 Northwest Territorial Mint, LLC (the "Debtor" or "NWTM"). Between June 19, 2014, and July 18,
2 2014, I made five purchases of silver and gold from the Debtor under sales order numbers 34526,
3 35611, 37753, 38420, and 38508. I have provided copies of my purchase orders to the Trustee.
4 Shortly thereafter, on July 22, 2016, I purchased two Liberty Franklin 50-gun safes to store precious
5 metals that I own. The serial numbers for the gun safes are #L001579791 and #L001610876. I
6 purchased the safes for \$5,599.90, which I paid with my Bank of America credit card. Attached
7 hereto as Exhibit A, is a copy of the invoice I received from NW Safe Company, Inc. for the sale of
8 the two gun safes.

9 4. Around the same time, I discussed with Ross Hansen, my need secure storage space.
10 In particular, I told him that I needed space for the two gun safes that would contain the precious
11 metals I had purchased from NWTM. Mr. Hansen gave me permission to store the two gun safes in
12 the Debtor's "Building B," located at 550 3rd St SW, Auburn, WA 98001. Mr. Hansen did not
13 charge me for rent or storage of my gun safes.

14 5. On or about August 7, 2014, NW Safe Company, Inc. delivered the two safes to the
15 Debtor. One of the Debtor's employees then accompanied a delivery truck to Building B, where I
16 met the delivery truck and the NWTM employee. The two safes were unloaded from the truck and
17 placed in Building B.

18 6. Over the course of the next couple of months, the precious metals I ordered between
19 June 19, 2014, and July 18, 2014, were delivered to Building B in multiple shipments. For each
20 shipment, I met a delivery truck at Building B and loaded precious metals into my two safes. I
21 recall that on more than one occasion, Dave Huffman accompanied the delivery truck and helped
22 me load my precious metals into my safes. On each occasion, once the precious metals I purchased
23 were loaded into the safes, I secured and locked the safes. I am the only person with the ability to
24 access the safes, and I never provided the combination(s) for the safes to any other person.

25 7. The safes contain precious metals that I have purchased from NWTM. To my

knowledge, the only other item in the safes, aside from perhaps some paperwork, is a dehumidifier I purchased from NW Safe Company that is listed on the attached invoice. Mr. Hansen did not store any of the Debtor's property in the safes, nor could he have done so given that I have all times been the only person with knowledge of the combination(s) that will unlock the safes.

8. I have agreed that, as a condition of the Trustee returning my safes and their contents to me, I will open the safes and let the Trustee view their contents. Before returning the safes and their contents, the Trustee will confirm that the contents of the safes consist solely of precious metals that I have purchased from the Debtor as evidenced by the sales records that I have provided to the Trustee and that are in the Trustee's possession.

I declare under penalty of perjury that the foregoing is true and correct.


