I am devastated at this point regarding The Northwest Territorial Mint case. I had put together \$5049.00 to purchase 350 ounces of silver from the mint. This is a pretty big purchase for me and I do not have the funds to replace it. I have recently retired and wanted to make this purchase.

On April 11, 2016 about 12:45 pm I called NWTM (800-843 9854) because my ship date was overdue. I was transferred to the bullion department and spoke to Darren. I was asking about a new ship date because I was not able to log into the web site to see for myself. Darren advised me of the bankruptcy they are going through. He told me they are not sending out any orders and giving no refunds. This I know is against their policy. Darren gave me this court case number.

On April 11, 2016 about 1:10 pm I called back and again spoke to Darren. I wanted to make an official plea to liquidate my silver purchase, as their policy provides. He told me he cannot do that. I asked what the normal protocol was to liquidate. He told me there is no form or letter to be filled out. He would simply take the request over the phone. I again told him of my request to do so, if this is how it is handled. Darren said he would not submit the request.

I have attached some documentation to show I am a victim in this case.

Any information would be greatly appreciated on what steps I can take at this point. You know, this is a classic case of the little guy that wanted something nice, and big business has the upper hand and screws you. I did research on the mint a while ago and understood this mint to be a very reputable company. I don't know what happened.
