Pursuant to the Court's Order Staying Case [D.E. No. 61], the parties hereby
submit their first joint status report regarding the stay of the case pending the resolution
of the pending criminal investigation of Hannes Tulving, Jr.

4 Since the Court issued the Order Staying Case, Mr. Tulving has continued his 5 discussions with prosecutors. Importantly, Mr. Tulving is now working with prosecutors 6 on the selection of an expert to value the significant amount of precious metals currently 7 in the possession of the federal government (i.e. in the possession of criminal 8 enforcement authorities and not in possession of the bankruptcy trustee). The 9 disposition of the precious metals in the possession of the government is important to 10 Plaintiff because such precious metals constitute the only potential assets for a class 11 recovery, and for that reason the parties request that the stay be continued, subject to 12 the ongoing reporting requirements as detailed in the Order Staying Case.
