5 accordance with the Auction Order, the proceeds of the Auction have been turned over to the Trustee
6 and the Auctioneer was reimbursed for its costs and paid its commission by virtue of the buyer's
7 premium in the amount of 19.5% added to each lot sold and retained by the Auctioneer, as
8 authorized by the Auction Order. The Trustee requests that the Individual Bond posted by the
9 Auctioneer be exonerated, and is lodging an order exonerating the Individual Bond concurrently
10 herewith, a copy of which is annexed hereto as **Exhibit B**.


3. I have compared the Auction Report (appended hereto as **Exhibit A**) to the items to be sold. The Auction Report is satisfactory.

The report of Heritage Numismatic Auctions, Inc. d/b/a Heritage Auctions ("Auctioneer"), respectfully represents as follows:

Auctioneer performed all acts required of it and has completed the auction ("Auction") of certain assets ("Assets") of the bankruptcy estate of the above-captioned debtor in accordance with the *Order Authorizing the Trustee to (A) Employ Heritage Numismatic Auctions as Auctioneer, and (B) Sell Certain Estate Property at Public Auction Outside the Ordinary Course of Business, Pursuant to 11 U.S.C. § 363(b), 327 and 328* [Docket No. 450] (the "Auction Order"). 2 p.m. Central Time on June 10, 2016, in accordance with the terms and conditions of the Auction.


3 The date of the Auction and awarding of lots to purchasers took place on June 10, 2016. All

I make this Declaration in support of the Report of Auctioneer and Auctioneer Expenses (the "Auctioneer Report"). Capitalized terms used herein shall have the meaning ascribed to them in the Auctioneer Report.

2. All facts set forth in this Declaration are based on either my personal knowledge (either my own or that gathered by agents and employees rendering services to me), upon my review of relevant documents, or upon my opinion based upon my experience or knowledge of the applicable circumstances. If I were called to testify thereto, I could and would competently do so.

3. I, through personnel employed by me, oversaw the Auction and the process leading up to it.

4. The Assets subject to the Auction consist of approximately 175,000 coins, both graded and ungraded modern coins from 1968 to the present. The Assets were sold in lots. On average, each lot contained 500-1,000 coins. Lot viewing was available between June 6, 2016 and June 10, 2016, and sealed bids were accepted until 5:00 p.m. Central Time on June 10, 2016, in accordance with the terms and conditions of the Auction.
