12 pursuant to 11 U.S.C. §§ 327 and 328(a).
- 13 3. VHA is authorized to conduct an auction of the Property outside the ordinary course of
14 business pursuant to 11 U.S.C. § 363(b).
- 15 4. The Property shall be sold free and clear of all liens, claims and interests pursuant to 11
16 U.S.C. § 363(f)(2).
- 17 5. The 14-day stay period imposed by Rule 6004(h) of the Federal Rules of Bankruptcy
18 Procedure is hereby waived.
- 19 6. This Court shall retain jurisdiction to decide any matters relating to the Motion or this
