DECLARATION OF JASON FLEET

14 Jason Fleet declares as follows:

15 1. I am over the age of 18 years old and, if called as a witness, could and would testify
16 to the matters set forth herein based on my personal knowledge. Unless otherwise stated herein, I
17 make the following statements based upon my personal knowledge.

18 2. I was employed as a graphic artist at Northwest Territorial Mint, LLC ("NWTM")
19 until in closed in late December, 2017. In early February, 2018, I was offered employment at Sierra
20 Mint in the capacity as a graphic artist. Sierra Mint sells challenge coins and other items which it
21 has manufactured in China. Paul Wagner, Marty Colwell, and I are the only employees of Sierra
22 Mint.

23 3. It is my job to take a design concept and create an image for delivery to the
24 manufacturer in China. The Chinese manufacturer then takes the design and creates a vector art file
25 which is used to manufacture the die with which the coin or other object is made. I get the art file


1 from the Chinese manufacturer and use it to create a proof for the customer.

2 4. I do not have copies of or access to any of Northwest Territorial Mint's art design
3 files, nor am I aware that anyone else at Sierra Mint that does. Sierra Mint works with new
4 customers to create a design concept. If a customer wants to order a design that the manufacturer
5 used to make for Northwest Territorial Mint, we will send the manufacturer a picture so it can create
6 new artwork or, if an art file already has been created by the manufacturer, it can use that file.

7 5. Neither I, nor to my knowledge any of Sierra Mint's employees, have ever taken
8 possession of or used assets of the bankruptcy estate other than in the course of employment at
9 NWTM.

10 I declare under the penalty of perjury under the laws of the United States that the foregoing is
11 true and correct to the best of my knowledge.
