## JURISDICTION AND VENUE

The Court has jurisdiction over the Sale Motion pursuant to 28 U.S.C. §§ 157 and 1334, and this matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2)(A), (M), (N), and (O). Venue of this case in this district is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

## LIMITED OBJECTION

On May 6, 2016, the Trustee filed the Sale Motion (Dkt. No. 200) which seeks authority to sell the Debtor's assets related to its business operation commonly referred to as Graco Awards Manufacturing located at 723 South Cherry Street, Tomball, Texas (the "Assets") to the Buyer. The proposed purchase price for the Assets is \$600,000 plus assumption of liabilities with an estimated value of \$150,000 (the "Purchase Price").

On May 10, 2016, the Court has been requested to shorten notice of the Sale Hearing (Dkt. No. 208), fixing May 23, 2016 as the deadline to file objections to the proposed sale of Assets to the Buyer. The procedures Order set a hearing on the Sale Motion for May 26, 2016 at 1:30 p.m (the "Sale Hearing").

IGI submits this limited objection to the Sale Motion to preserve its rights to submit a higher and better offer for the purchase of the Assets at the Sale Hearing. IGI intends to submit an offer to the Trustee in advance of the Sale Hearing that will provide a greater benefit to the Debtor's estate than the offer submitted by the stalking horse Buyer.
