I, Mark Calvert, hereby declare as follows:

1. I am the Chapter 11 Trustee (“Trustee”) of the Debtor, Northwest Territorial Mint, LLC (“Debtor” or “NWTM”). I submit this reply declaration in support of my Motion for Order Holding Ross Hansen in Contempt for Violation of the Automatic Stay (the “Motion”), and as further support for my assertion that the six boxes shipped by Ross Hansen to Dayton, Nevada on the eve of my appointment contained property that was purchased by the Debtor and is property of the bankruptcy estate.

2. I am presently in Dayton, Nevada, meeting with employees and other parties in connection with the business of the estate. While here, I re-inspected the contents of the six boxes that were shipped by Ms. Erdmann to Dayton on or about April 8, 2016. I compared the contents of the boxes with the purchase order to Mr. Robert Lee (the “Lee Purchase Order”) which was in the

1 one of the shipped boxes when they were opened and a copy of which is attached as Exhibit B to  
2 my original declaration. The Lee Purchase Order evidences the Debtor's purchase of certain items  
3 from Mr. Robert Lee, including ninety-four .999 fine miscellaneous sports items. I have reviewed  
4 the Debtor's banking records and confirmed that the Debtor paid Mr. Lee for the items ordered by  
5 the Debtor which are the subject of the Lee Purchase Order.

6 3. The Lee Purchase Order was enclosed in an envelope in one of the six boxes which  
7 Ms. Erdmann shipped to Dayton on April 8, 2016. The Lee Purchase order contains a line-item for  
8 "Silver 999 – MISCELLANEOUS SPORTS." The envelope in which the Lee Purchase Order was  
9 found also contained certificates of authenticity for certain sports memorabilia medallions made of  
10 .999 fine silver. For example, there are multiple certificates of authenticity for sports figures such as  
11 Ken Griffey, Jr.

12 4. I was able to locate, in the six boxes, some of the commemorative coins identified by  
13 the certificates of authenticity, including multiple Ken Griffey, Jr. commemorative coins. Attached  
14 hereto as Exhibit A are pictures of the Lee Purchase Order, certificates of authenticity, and some of  
15 the commemorative sports medallions that were contained in the six boxes.

16 5. This review of the contents of the six boxes has confirmed my belief that the six  
17 boxes contain property of the bankruptcy estate. As stated in my previous declaration, I am certain  
18 that Mr. Hansen directed the shipment of the six boxes to Dayton for the purposes of secreting them  
19 from me and obtaining his control over their contents.

20 I declare under penalty of perjury that the foregoing is true and correct.
