
BOND OF TRUSTEE

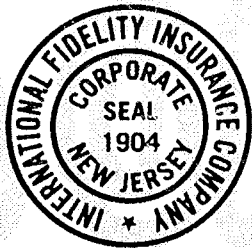

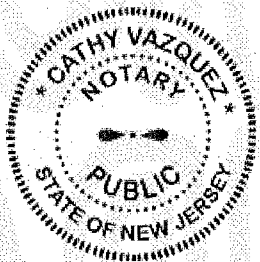
