1 Plaintiff Victor Hannan provides notice that Defendant The Tulving Company, Inc.
2 (“Tulving, Inc.”) has filed a petition for relief under Title 11, United States Bankruptcy
3 Court for the Central District of California that has been assigned case number 8:14-cv-
4 bk-11492-ES (the “Bankruptcy Action”) and suggests that this action against Tulving,
5 Inc. has been stayed by the operation of Title 11 U.S.C. §362.

6 Unless otherwise ordered by the Court, the Bankruptcy Action does not stay the
